New Sec. 6. (a) On and after September 15, 2020, during any state of 5 disaster emergency declared pursuant to K.S.A. 48-924, and amendments 6 thereto, the governor may not order the closure or cessation of any 7 business or commercial activity, whether for-profit or not-for-profit, for 8 more than 15 days. At least 24 hours prior to the issuance of such order, 9 the governor shall call a meeting of the state finance council for the 10 purpose of consulting with the council regarding the conditions 11 necessitating the issuance of such order. After such initial order or orders 12 providing for the closure or cessation of any business or commercial 13 activity have resulted in 15 days of such closures or cessation of business 14 or commercial activity, the governor may not order the closure or cessation 15 of business or commercial activity, except upon specific application by the 16 governor to the state finance council and an affirmative vote of at least six 17 of the legislative members of the council, the governor may order the 18 closure or cessation of business or commercial activity as approved by the 19 council for specified periods not to exceed 30 days each. 20

(b) Any order issued that violates or exceeds the restrictions provided
in subsection (a) shall not have the force and effect of law during the
period of a state of disaster emergency declared under K.S.A. 48-924(b),
and amendments thereto, and any such order shall be null and void.

(c) The provisions of this section shall expire on January 26, 2021.

New Sec. 7. Notwithstanding any other provision of law to the 26 contrary, no executive order issued by the governor pursuant to K.S.A. 48-27 925, and amendments thereto, that has the effect of closing public or 28 private school attendance centers in this state shall be effective unless and 29 until such order has been affirmed by the state board of education by 30 adoption of a resolution by a majority of the members of the state board. 31 Prior to issuing any such executive order, the governor shall submit such 32 proposed executive order to the state board of education. 1 (a) "Adult care facility" means a "nursing facility," "assisted living 2 facility" or "residential healthcare facility" as those terms are defined in 3 K.S.A. 39-923, and amendments thereto.

4 (b) "COVID-19" means the novel coronavirus identified as SARS-5 CoV-2.

6 "COVID-19 claim" means any claim for damages, losses, (c) 7 indemnification, contribution or other relief arising out of or based on 8 exposure or potential exposure to COVID-19. "COVID-19 claim" includes 9 a claim made by or on behalf of any person who has been exposed or 10 potentially exposed to COVID-19, or any representative, spouse, parent, 11 child or other relative of such person, for injury, including mental or 12 emotional injury, death or loss to person, risk of disease or other injury, costs of medical monitoring or surveillance, or other losses allegedly 13 caused by the person's exposure or potential exposure to COVID-19. 14

(d) "COVID-19 public health emergency" means the state of disaster
emergency declared for the state of Kansas on March 12, 2020, any

disaster emergency declared for the state of Kansas regarding the COVID19 pandemic.

20 (e) "Disinfecting or cleaning supplies" includes, but is not limited to, 21 hand sanitizers, disinfectants, sprays and wipes.

(f) "Healthcare provider" means a person or entity that is licensed,
registered, certified or otherwise authorized by the state of Kansas to
provide healthcare services in this state, including a hospice certified to
participate in the medicare program under 42 C.F.R. § 418 et seq.
"Healthcare provider" does not include any entity licensed under chapter
39 of the Kansas Statutes Annotated, and amendments thereto.

(g) "Person" means an individual, for-profit or not-for-profit business
entity, business trust, estate, trust, partnership, limited liability company,
association, joint venture, public corporation, government or political
subdivision, agency or instrumentality or any other legal or commercial
entity.

(h) "Personal protective equipment" means coveralls, face shields,
gloves, gowns, masks, respirators or other equipment designed to protect
the wearer from the spread of infection or illness.

(i) "Product liability claim" means any strict liability, ordinary
negligence or implied warranty claim or action brought for harm caused by
the manufacture, production, making, construction, fabrication, design,
formula, preparation, assembly, installation, testing, warnings, instructions,
marketing, packaging, storage or labeling of the relevant product.

41 (j) "Public health directives" means any of the following that is 42 required by law to be followed related to public health and COVID-19:

43 (1) State statutes, rules and regulations or executive orders issued by

1 the governor pursuant to K.S.A. 48-925, and amendments thereto;

2 (2) federal statutes or regulations from federal agencies, including the 3 United States centers for disease control and prevention and the 4 occupational safety and health administration of the United States 5 department of labor; or

6 (3) any lawful order or proclamation issued under authority of the 7 Kansas emergency management act, and amendments thereto, by a board 8 of county commissioners, the governing body of a city or a local health 9 officer.

"Qualified product" means: (1) Personal protective equipment 10 (k) used to protect the wearer from COVID-19 or the spread of COVID-19; 11 (2) medical devices, equipment and supplies used to treat COVID-19, 12 including products that are used or modified for an unapproved use to treat 13 COVID-19 or prevent the spread of COVID-19; (3) medical devices, 14 equipment or supplies utilized outside of the product's normal use to treat 15 COVID-19 or to prevent the spread of COVID-19; (4) medications used to 16 treat COVID-19, including medications prescribed or dispensed for 17 offlabel use to attempt to combat COVID-19; (5) tests used to diagnose or 18 determine immunity to COVID-19; (6) disinfecting or cleaning supplies; 19 (7) clinical laboratory services certified under the federal clinical 20 laboratory improvement amendments in section 353 of the public health 21 service act, 42 U.S.C. § 263a; and (8) components of qualified products. 22

In addition to those persons having standing 10 pursuant to K.S.A. 77-611, and amendments thereto, the examiner shall 11 have standing to obtain judicial review of an action of such board. The 12 review proceeding, and the questions of law certified, shall be heard in a 13 summary manner and shall be given precedence over all other civil cases 14 except cases arising under the workers compensation act. 15

(i) Any finding of fact or law, judgment, determination, conclusion or 16 final order made by the employment security board of review or any 17 examiner, special examiner, referee or other person with authority to make 18 findings of fact or law pursuant to the employment security law is not 19 admissible or binding in any separate or subsequent action or proceeding, 20 between a person and a present or previous employer brought before an 21 arbitrator, court or judge of the state or the United States, regardless of 22 whether the prior action was between the same or related parties or 23 involved the same facts. 24

(k) In any proceeding or hearing conducted under this section, a party 25 to the proceeding or hearing may appear before a referee or the 26 employment security board of review either personally or by means of a 27 designated representative to present evidence and to state the position of 28 the party. Hearings may be conducted in person, by telephone or other 29 means of electronic communication. The hearing shall be conducted by 30 telephone or other means of electronic communication if none of the 31 parties requests an in-person hearing. If only one party requests an in-32 person hearing, the referee shall have the discretion of requiring all parties 33 to appear in person or allow the party not requesting an in-person hearing 34 to appear by telephone or other means of electronic communication. The 35 notice of hearing shall include notice to the parties of their right to request 36 an in-person hearing and instructions on how to make the request. 37

Contributions shall accrue and become payable by each contributing employer for each calendar year-in which *that* the contributing employer is subject to the employment security law with respect to wages paid for employment. 1 the employment security fund in accordance with such rules and regulations as the secretary may adopt and shall not be deducted, in whole or in part, from the wages of individuals in such employer's employ. In the payment of any contributions, a fractional part of \$.01 shall be disregarded unless it amounts to \$.005 or more, in which case it shall be increased to \$.01. Should contributions for any calendar quarter be less than \$5, no payment shall be required.

8 (b) Rates and base of contributions. (1) Except as provided in 9 paragraph (2) of this subsection, each contributing employer shall pay 10 contributions on wages paid by the contributing employer during each calendar year with respect to employment as provided in K.S.A. 44-710a, 11 and amendments thereto. Except that, notwithstanding the federal law 12 requiring the secretary of labor to annually recalculate the contribution 13 rate, for calendar years 2010, 2011, 2012, 2013 and 2014, the secretary 14 shall charge each contributing employer in rate groups 1 through 32 the 15 contribution rate in the 2010 original tax rate computation table, with 16 17 contributing employers in rate groups 33 through 51 being capped at a 18 5.4% contribution rate. For calendar year 2021, unemployment tax rates 19 for eligible employers shall be limited to the standard rate schedule in K.S.A. 44-710a, and amendments thereto. Therefore, no additional 20 solvency adjustment shall be applied. 21

(2) (A) If the congress of the United States either amends or repeals 22 the Wagner-Peyser act, the federal unemployment tax act, the federal 23 24 social security act, or subtitle C of chapter 23 of the federal internal 25 revenue code of 1986, or any act or acts supplemental to or in lieu thereof, or any part or parts of any such law, or if any such law, or any part or parts 26 thereof, are held invalid with the effect that appropriations of funds by 27 congress and grants thereof to the state of Kansas for the payment of costs 28 of administration of the employment security law are no longer available 29 for such purposes; or (B) if employers in Kansas subject to the payment of 30 31 tax under the federal unemployment tax act are granted full credit against 32 such tax for contributions or taxes paid to the secretary of labor, then, and in either such case, beginning with the year-in which that the unavailability 33 of federal appropriations and grants for such purpose occurs or-in-which 34 35 that such change in liability for payment of such federal tax occurs and for each year thereafter, the rate of contributions of each contributing 36 employer shall be equal to the total of 0.5% and the rate of contributions as 37 determined for such contributing employer under K.S.A. 44-710a, and 38 amendments thereto. The amount of contributions-which that each 39 contributing employer becomes liable to pay under this paragraph (2) over 40 the amount of contributions-which that such contributing employer would 41 be otherwise liable to pay shall be credited to the employment security 42 43 administration fund to be disbursed and paid out under the same conditions

and for the same purposes as other moneys are authorized to be paid from the employment security administration fund, except that, if the secretary determines that as of the first day of January of any year there is an excess in the employment security administration fund over the amount required to be disbursed during such year, an amount equal to such excess as determined by the secretary shall be transferred to the employment security fund.

(c) Charging of benefit payments. (1) The secretary shall maintain a 8 separate account for each contributing employer, and shall credit the 9 contributing employer's account with all the contributions paid on the 10 contributing employer's own behalf. Nothing in the employment security 11 law shall be construed to grant any employer or individuals in such 12 employer's service prior claims or rights to the amounts paid by such 13 employer into the employment security fund either on such employer's 14 own behalf or on behalf of such individuals. Benefits paid shall be charged 15 against the accounts of each base period employer in the proportion that 16 the base period wages paid to an eligible individual by each such employer 17 bears to the total wages in the base period. Benefits shall be charged to 18 contributing employers' accounts and rated governmental employers' 19 accounts upon the basis of benefits paid during each twelve-month period 20 ending on the computation date. 21

(2) (A) Benefits paid in benefit years established by valid new claims 22 shall not be charged to the account of a contributing employer or rated 23 governmental employer who is a base period employer if the examiner 24 finds that claimant was separated from the claimant's most recent 25 employment with such employer under any of the following conditions: (i) 26 Discharged for misconduct or gross misconduct connected with the 27 individual's work;-or (ii) leaving work voluntarily without good cause 28 attributable to the claimant's work or the employer; or (iii) discharged 29 from an employer directly impacted by COVID-19 in accordance with the 30 families first coronavirus response act, public law 116-127. 31

(B) Where base period wage credits of a contributing employer or 32 rated governmental employer represent part-time employment and the 33 claimant continues in that part-time employment with that employer 34 during the period for which benefits are paid, then that employer's account 35 shall not be charged with any part of the benefits paid if the employer 36 provides the secretary with information as required by rules and 37 regulations. For the purposes of this subsection (c)(2)(B), "part-time 38 employment" means any employment when an individual works less than 39 full-time because the individual's services are not required for the 40 customary, scheduled full-time hours prevailing at the work place or the 41 individual does not customarily work the regularly scheduled full-time 42 hours due to personal choice or circumstances. 43

7 (D) No contributing employer, rated governmental employer or 8 reimbursing employer's account shall be charged for any additional 9 benefits paid during the period July 1, 2003 through June 30, 2004.

10 (E) No contributing employer or rated governmental employer's 11 account will be charged for benefits paid a claimant while pursuing an 12 approved training course as defined in-subsection (s) of K.S.A. 44-703(s), 13 and amendments thereto.

(F) No contributing employer or rated governmental employer's account shall be charged with respect to the benefits paid to any individual whose base period wages include wages for services not covered by the employment security law prior to January 1, 1978, to the extent that the employment security fund is reimbursed for such benefits pursuant to section 121 of public law 94-566 (90 Stat. 2673).

(G) With respect to weeks of unemployment beginning after 20 December 31, 1977, wages for insured work shall include wages paid for 21 previously uncovered services. For the purposes of this subsection (c)(2)22 (G), the term "previously uncovered services" means services-which that 23 24 were not covered employment, at any time during the one-year period ending December 31, 1975, except to the extent that assistance under title 25 II of the federal emergency jobs and unemployment assistance act of 1974 26 27 was paid on the basis of such services, and which that:

(i) Are agricultural labor as defined in-subsection (w) of K.S.A. 44 703(w), and amendments thereto, or domestic service as defined in
 subsection (aa) of K.S.A. 44-703(aa), and amendments thereto;

(H) No contributing employer or rated governmental employer's
account shall be charged with respect to their pro rata share of benefit

39 (3) An employer's account shall not be relieved of charges relating to40 a payment that was made erroneously if the secretary determines that:

41 (A) The erroneous payment was made because the employer, or the 42 agent of the employer, was at fault for failing to respond timely or 43 adequately to a written request from the secretary for information relating 4

15 (d) *Pooled fund.* All contributions and payments in lieu of 16 contributions and benefit cost payments to the employment security fund 17 shall be pooled and available to pay benefits to any individual entitled 18 thereto under the employment security law, regardless of the source of 19 such contributions or payments in lieu of contributions or benefit cost 20 payments.

21 (e) Election to become reimbursing employer; payment in lieu of 22 contributions. If an Indian tribe fails to make payments 8 required under this section, including assessments of interest and penalties, 9 within 90 days of a final notice of delinquency, the secretary shall 10 immediately notify the United States internal revenue service and the 11 United States department of labor. 29 (3) Allocation of benefit costs. The reimbursing account of each 30 reimbursing employer shall be charged the full amount of regular benefits 31 and 1/2 of the amount of extended benefits paid except that each reimbursing governmental employer's account shall be charged the full 32 amount of regular benefits and extended benefits paid for weeks of 33 unemployment beginning after December 31, 1978, to individuals whose 34 entire base period wage credits are from such employer. (A) Proportionate allocation (when fewer than all reimbursing base 5 period employers are liable). If benefits paid to an individual are based on 6 wages paid by one or more reimbursing employers and on wages paid by 7 one or more contributing employers or rated governmental employers, the 8 amount of benefits payable by each reimbursing employer shall be an 9 amount-which that bears the same ratio to the total benefits paid to the 10 individual as the total base period wages paid to the individual by such 11 employer bears to the total base period wages paid to the individual by all 12 of such individual's base period employers. 13

(B) Proportionate allocation (when all base period employers are 14 reimbursing employers). If benefits paid to an individual are based on 15 wages paid by two or more reimbursing employers, the amount of benefits 16 payable by each such employer shall be an amount-which that bears the 17 same ratio to the total benefits paid to the individual as the total base 18 period wages paid to the individual by such employer bear to the total base 19 period wages paid to the individual by all of such individual's base period 20 21 employers.

(4) Group accounts. "Rural health network" means an alliance of members, including 1 (e) at least one critical access hospital and at least one other hospital which, 2 that has developed a comprehensive plan submitted to and approved by the 3 secretary of health and environment regarding: Patient referral and 4 transfer; the provision of emergency and nonemergency transportation 5 among members; the development of a network-wide emergency services 6 plan; and the development of a plan for sharing patient information and 7 services between hospital members concerning medical staff credentialing, 8 risk management, quality assurance and peer review. 9

(f) (1) "Critical access hospital" means a member of a rural health 10 network-which that: Makes available-twenty-four hour 24-hour emergency 11 care services; provides not more than 25 acute care inpatient beds or in the 12 case of a facility with an approved swing-bed agreement a combined total 13 of extended care and acute care beds that does not exceed 25 beds; 14 provides acute inpatient care for a period that does not exceed, on an 15 annual average basis, 96 hours per patient; and provides nursing services 16 under the direction of a licensed professional nurse and continuous 17 licensed professional nursing services for not less than 24 hours of every 18 day when any bed is occupied or the facility is open to provide services for 19 patients unless an exemption is granted by the licensing agency pursuant to 20 rules and regulations. The critical access hospital may provide inpatient services by a 26 physician assistant, advanced practice registered nurse or a clinical nurse 27 specialist subject to the oversight of a physician who need not be present 28 in the facility. In addition to the facility's 25 acute beds or swing beds, or 29 both, the critical access hospital may have a psychiatric unit or a 30 rehabilitation unit, or both. Each unit shall not exceed 10 beds and neither 31 unit-will shall count toward the 25-bed limit, nor will these units or be 32 subject to the average 96-hour length of stay restriction. 33
