7. IV-Therapy Test Questions Survey

On May 19, 2021 a short survey was sent to all IV-Therapy Providers, requesting their input on the IV-Therapy Test Questions as they stand. Five IV-Therapy Providers completed the survey. The questions were:

- 1. In your opinion, do the IV-Therapy Test Questions need to be updated?
 - a. 80% yes, 20% no
- 2. What IV-Therapy Questions should be removed from the current IV-Therapy Test Questions?
 - a. "I don't believe at this point, since the test is asking very basic questions, any need to be removed."
- 3. What IV-Therapy Questions should be added to the current IV-Therapy Test Questions?
 - a. I think questions regarding infection control such as how long to scrub the hub and clean the skin is very important; want to prevent any infection and keep up with Infusion Nursing Standards on infection prevention.
 - b. I believe there should be more situation questions requiring the nursing process. Such as, "Patient receiving 'X' medications and while receiving/after discharge/when mixing, something changed (signs & symptoms of complications and incompatibility). What is your immediate response?'; more scope of practice questions; more questions which would require a nurse to look up information (really showing how important using Drug References are); more questions about sites to avoid; questions to help remember steps (SASH Method); diagram questions (locations).
 - c. Outpatient situations; care of PICC lines.
- 4. Would you be interested in serving on a taskforce for IV-Therapy Test Questions?
 - a. 60% yes, 40% no
