have been approved for KS PN programs

MidAmerica Naz: Request to add an additional credit hour to the TSBN Fundamentals

course and deducting one credit hour from another course so that the

overall program hours remain the same.

Rationale for Change: To align the TSBN course with the ASBN courses.

KCKCC: Request to eliminate NUPN 0134, 3 credit hours, adding Medical

terminology, application of assessment and clinical judgement, all 1 credit

hour each.

Rationale for Change: To align with the Core Curriculum and eliminate

redundancy of material.

It was moved to approve the Major Curriculum Change for Kansas City Community College to eliminate NUPN 0134, 3 credit hours, adding

Medical terminology, application of assessment and clinical judgement, all

Donnelly College: Request to add a daytime cohort of 25 starting August 2021.

Rationale for Change: To meet the need of the number of applying

applicants who would benefit from a daytime schedule.

Washburn Grad.:

Newman Grad.:

Request to transition from entry-level master's program to entry-level doctoral program.

Rationale for Change: To align with the requirements of the Council on Accreditation of Nurse Anesthesia Educational Programs (COA) directive.

It was moved to approve the Major Curriculum Change for Newman University, Graduate Program, to transition from entry-level master's program to entry-level doctoral program. Motion #14 Bragdon/Kidder Adopted.

Seward CCC:

Request to revise level I and level II nursing courses, providing a structured "build upon" education across the lifespan, providing cohesive active learning.

Rationale for Change: An assessment of current curriculum identified "silo teaching and learning" for faculty and students, and data shows more students are struggling to succeed in this type of environment. Current faculty inherited a program that is over 10 years old and current faculty have been working to update and improve curriculum content and flow. The new structure will help control content overload and reduce redundancy in teaching topics. New curriculum plan provides more emphasis on clinical judgment while offering more general bedside nursing opportunities which are both essential to novice nurse graduates to effectively integrate into safe nursing practice.

It was moved to approve the Major Curriculum Change for Seward County Community College to revise level I and level II nursing courses, providing a structured "build upon" education across the lifespan, providing cohesive active learning. Motion #15 Bohnenblust/Kidder Adopted.

J. Martin updated the committee on the new annual report template for nursing programs. KSBN has been working with NCSBN on a new annual report that will incorporate Core Data for nursing programs into a national nursing program database. Kansas will be one of 11 pilot states to implement an Annual Report that will include the Core Data. NCSBN will provide reporting to KS on their Core Data as well as providing annual reports of all programs submitting Core Data. The first report is planned for Fall 2021 and will include Kansas data. Orientation webinars are being planned by KSBN for all Nursing Program Administrators and will include support from NCSBN.

Fall 2021 Site Visits: A discussion was held regarding in-person or virtual site visits for the Fall

2021 schedule. A decision was tabled until June 2021.
