PMP Committee Report:

CNM-I Regulations:

C. Moreland reported there was nothing new to report on the CNM-I Regulations. The last time they met was in March 2023.

Graduate Preceptor:

C. Moreland reported on Graduate Preceptor Qualifications -K.A.R. 60-17-104. There has been a request from some Graduate Programs who wanted to use Physician Assistants as preceptors. Currently to be a preceptor to a graduate nursing student they must be either a APRN or a Physician. Item was tabled to March 2024 to allow more information on the subject.

Clinical Hours Requirement: C. Moreland reported on Clinical Hours Requirement – Draft K.A.R. 60-17-105 Revision. Presently we require 500 clinical hours in each clinical track, however, a recommendation was made that this be increased to 750 clinical hours and have it for direct patient care practice hours and not just clinical hours. Item was tabled to March 2024 to all more data on the subject.
