## **Unfinished Business:**

PMP Committee Report:

C. Moreland reported there was nothing to report as the APRN Committee currently has a vacancy for this position. If anyone knows of anyone who might be interested in this vacancy, let Carol know.

**CNM-I Regulations:** 

C. Moreland reported there was nothing new to report on the CNM-I Regulations. Carol has reached out to the Board of Healing Arts (KSBHA) for an update on the three regulations that is awaiting changes with the Independent Practice of Midwifery Advisory Council. The Board of Nursing is waiting to hear back from KSBHA and has not heard back from them. The last time the CNM-I Council met was March 2023.

**Graduate Preceptor:** 

C. Moreland introduced Jenny Manry, DNP, APRN, FNP-BC, Program Administrator, Fort Hays State University who reported on Preceptors and the proposal to increase the number of clinical hours to 750. K.A.R. 60-17-104, Administrator, Faculty and preceptor qualifications and K.A.R. 60-17-105, Curriculum requirements are the two regulations that would need to be changed to increase the number of clinical hours.

It was moved to revised K.A.R. 60-17-104 to state preceptors can be M.D, D.O., APRN or licensed health professions with a health science degree at master's level or above.

Motion #2 Fritz/Hysten Adopted

It was moved to revised K.A.R. 60-17-105 to require 750 practice hours in curriculum. Number of hours over 750 can be precepted with a licensed interdisciplinary professional with a health science degree at a master's level or higher. Practice of 750 or below must be precepted with a M.D., D.O., or APRN. Motion #3 Fritz/Hysten Adopted.
