Annual NCLEX Report:

C. Moreland gave an update on NCLEX reports. 2023 pass rates are up. Programs that fall below the 80% cutoff for one year, per regulation, receive a written notice of concern from the board, and the program has 3 months to submit a written report analyzing their program. and the plan of action. J. Rieschick commented that only 2 programs did not meet the pass rate, but those programs are already working with the board and have been working and sharing progress along the way: both have seen increased rates from prior years.

J. Martin will draft and send a letter to these programs stating that KSBN is encouraged by improvements and hope that continues.

KACN Request:

Three individuals representing KACN presented brief information they have gathered and reviewed regarding 1 credit for simulation clock hours. Education Committee Chair, J. Rieschick, requested information be gathered and brought back prior to June meeting, after looking at other states within the compact.

Regulation Review:

K.A.R. 60-2-106, K.A.R. 60-2-107, and K.A.R 60-2-108 were discussed and reviewed. Final drafts will be reviewed at the June board meeting.

Unfinished Business:

Fort Scott CC-plan update:

Representatives from Fort Scott spoke regarding their strategic plan. They have created a nursing task force, as well as regular faculty meetings and meetings with student representatives monthly. Reported 100% pass rate with most recent cohort this past semester. Positive changes have been made following site visit. Requested admission of 20 students for Fall of 2024.

It was moved to approve Fort Scott as being allowed to accept 20 students in the fall of 2024 to pilot their changes.

APRN revised education regulations:

C. Moreland presented on the APRN revised education regulations. The USDOE approved KSBN to continue as an approved organization under their rules with a report to be submitted in 12 months showing we are in compliance with regulations pertaining to the APRN reporting in the KNPA. Draft revision have been on the books but not approved to date. These changes are needed to bring KSBN into compliance with USDOE standards.

It was moved to approve the revisions of KAR 60-17-101, 102,103, 104, 105, 106, 107, 108, 109 as presented. Motion #24 Palmietto/Pile Adopted

LMHT draft regulations:

C. Moreland spoke on LMHT draft regulations and the desire for common language to be developed. An effort was made to combine regulations, rather than add additional regulations. It was discussed that the number of required didactic and clinical hours that are currently in the regulations (and being used by 2 programs) may be too much to make it user friendly and more compatible with current expectations in other healthcare programs. Past discussion was regarding how to make more of the course work/clinical eligible for college credit. J. Martin stated that a couple of schools have expressed interest to her in terms of trying to bring LMHT into the college/community college setting to provide and offer credit for that program (somewhere between the CMA/LPN levels). A subcommittee was discussed. A representative from the current program, those programs that have expressed interest, as well as employers that could offer insight, would be encouraged to join. Committee Members R. Burkhart and D. Pile offered assistance in participating and serving on the sub-committee.
