## Who are APRNs in Kansas 60-11-102

The four roles of advanced practice registered nurses licensed by the board of nursing shall be the following:

- (a) Clinical nurse specialist;
- (b) nurse anesthetist;
- (c) nurse-midwife; and
- (d) nurse practitioner.

(Authorized by and implementing K.S.A. 65-1113, as amended by L. 2011, ch. 114, sec. 39, and K.S.A. 65-1130, as amended by L. 2011, ch. 114, sec. 44; effective May 1, 1984; amended Sept. 4, 2009; amended May 18, 2012.)

## What is required by the Board of Nursing to Practice as an APRN in Kansas

- **60-11-103 Licensure and educational requirements for advanced practice registered nurses.** (a) **Licensure as an advanced practice registered nurse.** Each applicant for licensure as an advanced practice registered nurse shall meet the following requirements:
  - (1) File with the board a **completed application on a form** adopted by the board and pay the application fee prescribed by K.A.R. 60-11-119;
  - (2) be **fingerprinted** and submit to a state and national criminal history record check;
  - (3) submit **proof of APRN certification** in the applicant's specific role and population focus granted by a national certifying organization that is recognized by the board and whose certification standards are approved by the board as equal to or greater than the corresponding standards established by the board for initial licensure applications submitted on and after July 1, 2023;
  - (4) submit **proof of malpractice insurance coverage** if the applicant renders professional clinical services as an APRN, unless the advanced practice registered nurse meets one of the exceptions listed in K.S.A. 65-1130 as amended by 2022 S Sub for HB 2279, sec. 1, and amendments thereto; and
  - (5) within **180 days** after the board's receipt of the application, **submit proof that all qualifications for licensure**, as specified in K.S.A. 65-1130 and K.S.A. 65-1131 and amendments thereto, **have been met**. If the applicant does not meet this requirement, the application shall be deemed abandoned and closed.
- (b) Licensure in the roles of clinical nurse specialist, nurse anesthetist, nurse-midwife, and nurse practitioner. To be issued a license as an advanced practice registered nurse in any of the roles of advanced practice, as identified in K.A.R. 60-11-102, each applicant shall meet at least one of the following requirements:

## What is required by the Board of Nursing to Practice as an APRN in Kansas

- (1) Complete a formal, post-basic nursing education program located or offered in Kansas that has been approved by the board and prepares the nurse to function in the advanced role for which application is made;
- (2) complete a formal, post-basic nursing education program that is not located or offered in Kansas but is determined by the board to meet the standards for program approval established by K.A.R. 60-17-101 through 60-17-108;
- (3) have completed a formal, post-basic nursing education program that is no longer in existence but is determined by the board to meet standards at least as stringent as those required for program approval by the board at the time of graduation;
- (4) hold a current license to practice as an advanced practice registered nurse in the role for which application is made and demonstrate to the board's satisfaction that both of the following requirements are met:
  - (A) The license was issued by a nursing licensing authority of another jurisdiction; and
  - (B)(i) The licensee completed a program meeting standards equal to or greater than those established by K.A.R. 60-17-101 through 60-17-108; or
  - (ii) the applicant has met the requirements for licensure pursuant to K.S.A. 48-3406, and amendments thereto; or
- (5) complete a formal educational program of post-basic study and clinical experience that can be demonstrated by the applicant to have sufficiently prepared the applicant for practice in the role of advanced practice for which application is made. The applicant shall show that the curriculum of the program is consistent with public health and safety policy and that the program prepared individuals to perform acts generally recognized by Page 137

The approved KSBN National Certification Organizations are as follows: *American Academy of Nurse Practitioners Certification Board (AANPCB), American Association of Critical-Care Nurses (AACN), American Midwifery Certification Board (AMCB), American Nurses Credentialing Center (ANCC), National Board of Certification & Recertification for Nurse Anesthetists (NBCRNA), National Certification Corporation (NCC), Pediatric Nursing Certification Board (PNCB)*

**Pursuant to K.A.R. 60-3-107(b) applications for licensure while awaiting documentation of qualifications are active for 6 months. The expiration date of each application is based upon the date of the receipt at the agency. Once the application has expired, a new application and application fees are required.**

## WHAT ARE CONTROLLED/SCHEDULED MEDICATIONS?

Each of the five schedules has parameters based on their medical value, the risk of addiction, and the ability to cause harm. The schedules range from Schedule I (most potential for addiction/use disorder) to Schedule V (least potential for addiction/use disorder).

4

## SCHEDULE I MEDICATIONS

### Schedule I

- Schedule I drugs possess the highest potential for use disorder and misuse. They have no medical use and are illicit or "street" drugs.
- Examples of Schedule I drugs include heroin, lysergic acid diethylamide, mescaline, methylenedioxymethamphetamine (MDMA), and methaqualone.
- Marijuana, which is legal in some states, is still classified as a Schedule I drug at the federal level as of this writing.*

5

## SCHEDULE II MEDICATIONS

### Schedule II

- Schedule II drugs have a reduced potential for use disorders than Schedule I. They are at high risk for both physical and psychological dependence. They have a high capacity for both use disorder and misuse. They are typically prescribed to treat severe pain, anxiety, insomnia, and ADHD.
- Examples of Schedule II substances include fentanyl, hydromorphone, meperidine, methadone, morphine, oxycodone, fentanyl, dextroamphetamine, methylphenidate, methamphetamine, pentobarbital, and secobarbital.
- They previously had to be prescribed only via paper prescription but now are permitted to be electronically transmitted. (Electronic Prescribing of Controlled Substances or EPCS).
- No refills are allowed.
- Schedule II drugs have the tightest regulations when compared to other prescription drugs.

## SCHEDULE III MEDICATIONS

### Schedule III

- Schedule III drugs have a lower misuse potential than I and II. Drugs in this category may cause physical dependence but more commonly lead to psychological dependence. Medications in this category are often used for pain control, or anesthesia, or appetite suppression.
- Examples of Schedule III substances include benzphetamine, ketamine, phendimetrazine, and anabolic steroids.
- Opioid analgesics in this schedule include products containing not more than 90 milligrams of codeine per dosage unit and buprenorphine.
- Schedule III drugs are prescribable verbally over the phone, with a paper prescription, or via EPCS.
- Within a six-month time frame, refill requirements are such that the drug can only have five refills.

7

## SCHEDULE IV MEDICATIONS

### Schedule IV

- Schedule IV drugs have an even lower misuse potential than I, II, or III. They have a limited risk of physical or psychological dependence.
- Examples of Schedule IV substances include: alprazolam, carisoprodol, clonazepam, clorazepate, diazepam, lorazepam, midazolam, temazepam, tramadol, and triazolam.
- Drugs in this class may be utilized for pain control as long as the provider deems the drug medically necessary and the patient would benefit.
- Schedule IV drugs are prescribable verbally over the phone, with a paper prescription, or via EPCS.
- Refills are permitted up to five times in a six-month timeframe from the issuance date.

## SCHEDULE V MEDICATIONS

### Schedule V

- Schedule V drugs are the least likely of the controlled substances to be misused. They result in very limited physical or psychological dependence.
- Examples include cough medicines with codeine, antidiarrheal medications that contain atropine/diphenoxylate, pregabalin, and ezogabine.
- Despite their low abuse potential, they still need to be managed appropriately and administered with care.
- When they contain codeine, it must have less than 200 mg of codeine per 100 mL.
- Partial prescription fills cannot occur more than six months after the issue date. When a partial fill occurs, it is treated in the same manner and with the same rules as a refill of the drug.

## WHAT IS THE DEA?

The mission of the Drug Enforcement Administration (DEA) is to enforce the controlled substances laws and regulations of the United States and bring to the criminal and civil justice system of the United States, or any other competent jurisdiction, those organizations and principal members of organizations, involved in the growing, manufacture, or distribution of controlled substances appearing in or destined for illicit traffic in the United States; and to recommend and support non-enforcement programs aimed at reducing the availability of illicit controlled substances on the domestic and international markets.

## HOW DO I GET A DEA NUMBER?

A DEA Registration Number is a unique identifier provided by the Drug Enforcement Agency to medical practitioners like pharmacists, nurse practitioners, doctors, dentists, etc... allowing them to prescribe, dispense and administer drugs defined to be Controlled Dangerous Substances (CDS). To obtain a DEA registration number go to:

## WHAT IS AN NPI NUMBER?

A National Provider Identifier (NPI) is a unique identification number for covered health care providers, created to help send health information electronically more quickly and effectively. Covered health care providers, all health plans, and health care clearinghouses must use NPIs in their administrative and financial transactions.

To bill insurances, Medicaid/Medicare this number is required.

## HOW DO I GET A NPI NUMBER?

### **Applying Online:**

To complete the online NPI application, you must first obtain an Identity & Access (I&A) User ID. You may obtain this User ID by accessing <https://nppes.cms.hhs.gov> and completing steps 1-4 on the following slide:

## HOW DO I GET A NPI NUMBER CONTINUED?

Select the Create a Login link on the Individual Provider side of the National Plan and Provider Enumeration System (NPPES) Home page.

Note: You will be redirected to the I&A website.

- Follow the steps to complete your I&A Registration.
- Once you have successfully obtained an I&A User ID, you may return to the NPPES Home page and log into the NPPES website with your newly created I&A User ID.
- Select the Submit a New NPI Application to begin the NPI application process

If you obtain and NPI number as an RN you can change it to APRN after you are licensed, this will expedite your processes as an APRN.

# Questions for KAPN

## What is Full Practice Authority?

Full Practice Authority is generally agreed to be defined as Advanced Practice Registered Nurses (APRNs) authorization to utilize knowledge, skills, and judgment to practice to their full extent of their license, education and training to evaluate, treat, interpret testing results and diagnose patients independently without a supervising physician.

April 29, 2022 the Kansas Governor Laura Kelly signed into law House Bill 2279 into making Kansas the 26<sup>th</sup> state in the United States. July 1, 2022 full practice authority for APRNs in Kansas began.

Places of employment may continue to require collaborative practice agreements between APRNs and physicians but the law in Kansas no longer requires. As of July 1, 2024 APRNs are authorized to sign Kansas death certificates. There are still a few things APRNs can't do like order diabetic shoes.

# Questions for KAPN

## What do I do if I don't Pass My Boards?

Passing boards can be a very intimidating time for new APRNs. What do you do if the worst happens, and you don't pass. Each credentialing body processes unique methods regarding next steps, but information on many of them are below.

To practice as an APRN in Kansas you are required to have the following:

- ❖ Completed application form
- ❖ Submit official fingerprints
- ❖ Submit proof of APRN certification directly from certifying body
- ❖ Submit proof of malpractice insurance coverage

AMCB allows an additional attempt to successfully complete the exam 30 days after the first failure.

AANCCP allows 3 attempts per year to achieve successful complete of the exam with the second attempt 60 months after the first failure.

AANPCB allows 2 attempts to achieve successful completion of the exam.

NBCRNA allows 1 additional attempt to successfully complete the exam and the APRN is required to take additional Class A credit beyond the required 60.

**60-7-101. Licensure.** (a) The applicant shall file with the board one month preceding the examination a completed application on an adopted form with payment of the application and examination fees prescribed by K.A.R. 60-8-101.

(b) Verification of current Kansas license shall be provided by request to other state boards upon payment of fee.

(c) Information regarding examinations.

(1) The examination for licensure shall be given at least twice a year.

(2) Each candidate shall present a validated admission card in order to be admitted to the examination center.

(3) Any applicant cheating or attempting to cheat during the examination shall be deemed not to have passed the examination.

(4) In the event that answer sheets are lost or destroyed through circumstances beyond the control of the board, the candidate shall be required to retake the examination in order to meet requirements for licensure, except that no additional charge shall be made.

(5) Individual examination results shall be released to the school from which the examinee graduated.

(6) Any candidate requesting modifications to the examination procedures or materials because of a learning disability shall provide written documentation from the appropriate medical professional confirming the learning disability, an evaluation completed within the last five years by a learning disabilities evaluation team, and a letter from the mental health technician program confirming the learning and testing modifications made during the course of study.

(d) Application for retest. An applicant who fails to make a passing score on the licensure examination may retake the examination and shall pay an examination fee for each retest as established by K.A.R. 60-8-101.

(e) If an individual fails to pass the licensure examination within 24 months from graduation, the individual shall petition the board in writing before being allowed to retake the licensure examination. The petition shall be on a form provided by the board and shall contain the following:

(1) The name of the school of graduation;

(2) the date of graduation;

(3) the number of months or years since graduation;

(4) the number of times taking the licensure examination;

(5) the dates of the licensure examinations;

(6) areas of deficiency identified on the diagnostic profile for each examination;

(7) copies of all diagnostic profiles;

(8) any study completed since the last attempt of taking the licensure examination;

(9) any work experience in the last two years; and

(10) a sworn statement by the petitioner that the facts contained in the petition are true to the best of the person's knowledge and belief.

(f) An individual shall be allowed by the board to retake the licensure examination after 24 months from graduation only upon demonstrating to the board's satisfaction that the individual has identified and addressed the reasons for prior failure and that there is a reasonable probability that the individual will pass the examination. A plan of study may be required by the board before the individual retakes the licensure examination.

(g) If the board requires a plan of study before retaking the licensure examination, the plan shall contain the following:

(1) A list of all the low performance competencies of the test plan identified by the diagnostic profile from each examination;

(2) a specific content outline for all the low performance competencies on the diagnostic profile;

(3) methods of study, including the following:

(A) Self-study;

(B) study groups;

(C) tutors; or

(D) any other methods as approved by the board;

(4) a schedule for study that meets the following requirements:

(A) 30 hours per each low performance competency;

(B) a start date; and

(C) completion in six months or the petition shall be considered abandoned;

(5) learning resources identified to be used in the study, meeting these requirements:

(A) a written bibliography in a standard documentation format, with resources no more than five years old; and

(B) four types for each low performance competency selected from the list as follows:

(i) Textbooks;

(ii) journals;

(iii) review books;

(iv) audiovisuals;

(v) computer-assisted instruction; or

(vi) computer review programs.

(h) A registered professional nurse shall provide written verification that the individual has completed a study plan.
