C. Moreland reported on the CNM-I Regulations. Carol has reached out to the Board of Healing Arts (KSBHA) for an update on the two regulations that has not been approved by both Boards. The Board of Nursing is waiting to hear back from KSBHA on K.A.R. 100-28b-8 and K.A.R. 100-28b-9. The last time the CNM-I Council met was November 2023 which there was no quorum at that time.

C. Moreland reported on the vacancies on the CNM-I Council. There are nine CNM-I that are licensed at KSBHA whose license at KSBHA will expire on September 30, 2024. Carol has emailed them asking if they would be interested in representing KSBN on the CNM-I Council and have not heard back from any of them at this time.
