Executive Administrator Report

Purpose of the Agenda Item and/or the Board Action Requested:

This report is an update on the activities of the Executive Administrator for March 2025 through May 15, 2025, to support KSBN strategic plan.

Board Action requested: Decision as to the attendees for Annual Meeting. Travel requests must be submitted by July 7

Strategic Outcome and actions taken to support the strategic outcome:

Strategic Objective 1 – 1 Enhance collaborative relationships with other nursing and health-related organizations in Kansas

- Conducted first meeting of the IV Task Force to understand concerns of IV Therapy providers with current regulations and competency assessment methods
- Attended a virtual meeting with representatives of the National Task Force on Quality Nursing Practitioner Education – they congratulate and thank the KSBN for being the first BON in the nation to implement the increased number of clinical hours to 750 for advanced practice education programs. They consider the KSBN to be a leader in the nation and hope others will now follow by implementing the recommendations

Strategic Objective 1 – 2 Systematic evaluation of advanced practice nursing

- Communication developed regarding scope of practice change for CRNAs to include prescriptive authority. This change will be effective when published in the statute book (July 1, 2025). Communication placed in June newsletter and KSBN website

Strategic Objective 2 – 1 Monitor the Board's report of financial position:

- Prepared licensure fee and budget information for discussion at the strategic retreat

Strategic Objective 2 – 4 Recruit, develop and retain qualified staff:

- Leadership Team is evaluating revision of telework policy and agreement
- Leadership Team is evaluating new agency policies that would provide guidance and clarification to staff
- Implementing 2026 Pay Plan changes passed by Legislature with the guidance of Division of Personnel Services

Strategic Objective 2 – 5 Maintain a superior and secure information technology infrastructure:

- Attended OITS monthly security webinars to increase my knowledge

Strategic Objective 3 – 5: Communication provided is high quality, clear, accurate, current and includes effective methods available to give feedback to the Board:

- Continue to provide information and attend status meetings with Legislative Post Auditors for the Abuse, Neglect and Exploitation Registry LPA
- Follow-up meeting with KBI about results of FBI audit conducted in March. K.S.A. 74-1112 needs revised to include advanced practice registered nurses and add a definition of applicant. I will work with KBI and Revisor's Office to bring a draft in September for your review.
