Unfinished Business:

K.A.R. 60-9-106 Revision Update

C. Moreland gave an update on the revisions to K.A.R 60-9-106 which are in both CNE and APRN committees. Items in the regulation were deleted (such as American Heart Association) and others added (such as BLS courses not being accepted as CNE). Discussion was had and it was decided to move forward with the approval process after reviewed by APRN committee.

Update on 2024 Delinquent CNE Providers

C. Moreland discussed delinquent providerships not in compliance with KSBN regulation regarding the 2024 annual report and fee. C. Moreland stated 6.22.2025 is the deadline for providers to submit their 2024 annual report and payment, or approval will be pulled. The board directed Carol to move forward with the necessary steps to revoke providerships, if deadline is not met.

IV Therapy Subcommittee Update:

C. Moreland stated the subcommittee met on 5.1.2025 to look at regulations 60-16-101 and 60-16-102. They are working to add definitions and clarification to the regulation.

Committee also wants to look at reviewing the IV therapy test and work with IV providers to assemble a task force of stand-alone and PN curriculum providers and develop a test and competency checklist. This would most likely be a different task force.

C. Moreland stated she will work on draft of changes to regulations that she will send out to subcommittee for review and feedback and bring back in September.
