Galen College ADN:

The March 11-12, 2025, follow up after first graduation site visit report for Galen College, ADN program, was reviewed. Site visitors were Mechele Hailey, DNP, RN and Janelle Martin, MHSA, RN.

Flint Hills Technical College PN:

Cloud County Community College PN level:

Fort Scott Community College:

Request to

-change the in-course sequencing, leveling and distribution of Medical Surgical Nursing content across 3 semesters (instead of 2), without a change in total credit hours -Move all courses face-to-face with the exception of NSG2542 Nursing Leadership and Management, which will be a hybrid course; and

-Move to an annual admission process in the Fall (no spring admits) after a site visit is done to confirm all recommendations are complete per board action

It was moved to approve the Major Curriculum Change Request from Fort Scott Community College ADN program to: 1) change the in-course sequencing, leveling and distribution of Medical Surgical Nursing content across 3 semesters (instead of 2), without a change in total credit hours.

2) Move all courses to face-to-face format with the exception of NSG2542 Nursing Leadership and Management, which will be a hybrid course; and 3) Move to an annual admission process in the Fall (no spring admits) after a site visit is done to confirm all recommendations are complete per board action.

University of Saint Mary:

Request to allow hybrid (remote synchronous and asynchronous) presentation of BSN content, and an additional spring start date.

It was moved to approve the Major Curriculum Change Request from the University of Saint Mary BSN program to allow hybrid (remote synchronous and asynchronous) presentation of BSN content and add an additional spring start date with no increase to approved number of annual admissions.

Motion #13 Murray/Pile Adopted Kidder: Abstain

WSU Tech

Request to expand the ADN program by 30 seats to allow a better balance with the PN program.

It was moved to approve the major curriculum change request from WSU Tech ADN program to decrease the number of admits to the PN program from 80 to 55 each semester (up to 110 annually) and expand the ADN level by 30 seats and allow for a spring admission which would offer 60 seats annually.

Motion #14 Terry/Kidder Adopted

Five Year Legislative Review

- 1. 60-5-102 Approval procedure (LMHT)
- 2. 60-6-101 Requirements (LMHT)
- J. Martin stated the board is still working on a review process for regulations that would align with the new legislative requirement to review all regulations every 5 years for necessity. It was suggested that discussion be held until September meeting to hopefully reduce re-work. Board agreed to table discussion and place on agenda for September.

Unfinished Business:

NCLEX Improvement Plan Reports:

Seward County Community College, ADN Program

A representative from Seward County Community College was present to discuss their improvement plan packet. The plan included providing greater academic support for students, implementation of ATI, and support for the high number of ESL students. SCCC also decided to raise the admission GPA from 2.5 to 3.0. KSBN will look at pass rates again in March.

Mid-America College of Health Sciences, PN Program

Representatives from MACOHS were present and discussed their improvement plan summary. Representatives discussed their transition to Lippincott which they believe will lead to better benchmarks for success. MACOHS also mentioned raising the admissions criteria, as well as encouraging students to not delay testing after graduation. There was also a consultant recommendation to provide more focused education to the faculty on teaching and learning strategies in nursing education. Board asked for an update on the improvement plan be done for the Site Visit in Spring of 2026 with a focus on NCLEX pass rates and timeliness of testing by students.

Donnelly College, ADN and PN programs

Representatives from Donnelly College were present to address concerns within the program and to provide an NCLEX improvement plan as well as an update on the evaluation plan for nursing. Donnelly College

presented a Five Pillar Action Plan including improving student engagement, satisfaction, and morale; stabilize current faculty and recruit and retain qualified educators; improve student academic performance and NCLEX pass rates; expand SIM Lab; and Implement program evaluation to track progress. Requested data was not in the evaluation plan. Discussion was held regarding the continued complaints received on the Donnelly programs. Most complaints still refer to the program as disorganized and have uncertainty about the quality of faculty. Board upheld the decision made at the March meeting to cease admissions to both programs and focus on currently admitted students until the program is stable for at least 6 months with a site visit to be done before re-starting admissions. The Board will review the NCLEX data for Donnelly in September and decide if admission in January is a possibility even if a site visit cannot be completed prior to the January date.

LMHT Task Force-

Ruth Burkart gave an update on the LMHT Task force, and those members involved with this committee. R. Burkhart gave suggestions and recommendation on behalf of the Task force after meeting together.

The Board recommended KSBN engage in discussion with KDADS prior to September's meeting regarding the task force recommendation to sunset the LMHT license going forward and see if KDADS would consider managing an MHT certificate for this level of provider.

This recommendation would require that KSBN provides a means for ongoing support for renewal of currently licensed LMHTs and that currently approved LMHT programs offer a teach-out option for those that are currently enrolled.

Follow Up on the 2:1 hour for simulation

J. Martin gave an update on her findings and presented information through the onsite packet. The Board discussed concerns with the 2:1 simulation and gave a reminder that it is still 1:1 in Kansas.

KNPA- Approved changes to regulations with approval dates

KAR 60-3-114 Refresher Course (amended 1.31.2025)

A change was made to the refresher course requirements that were implemented Jan. 31, 2025. This change will open up more opportunities for other providers that may fit the new refresher criteria.

KAR 60-17-101 to 60-17-109 (amended 2.7.2025)

All changes have been approved and are in effect, including the increase in curriculum hours for APRN programs which went into effect in February with March 1st, 2025, as a cutoff date for those in APRN programs currently. All those starting APRN programs after the 3/1/25 date will fall under the new regulations for clinical hours of 750.
