**Call to order:** The CNE & IV Therapy Committee meeting was called to order by Andrea Watson, Chair, at 12:30 in Room 509 of the Landon State Office Building and via Zoom.

**Consent Item Agenda:** C. Moreland reviewed the consent item agendas. She stated the majority of IOA's are for college courses, and only a few IOA's were denied this period. She also stated a different format is being released soon for submitting IOA's.  
C. Moreland stated 4 Single Providers were approved this period, only a few CNE relinquishments were had (which puts the total of providers around 100), and there has been no IV relinquishments or new IV therapy providers.

It was moved to approve the Consent Item Agenda which included: IOA Statistical Report, Single Providers Approved 5/25-8/25, and Provider Relinquishments.

**Unfinished Business:**

K.A.R. 60-9-106 Revision Update

C. Moreland stated regulation K.A.R 60-9-106 is still going through the approval process.

Update on 2024 Delinquent CNE Providers:

C. Moreland stated the names of delinquent CNE providers have been given to our general counsel to end providership. For those delinquent providers that reached out after the deadline and would like to continue a providership, they will need to submit another application.

Update on the status of the IV Task Force:

IV task force met and began looking at the regulations first. They discussed adding definitions into the regulations to prevent any confusion and clarify the terminology used in the regulations. The task force will meet again. Following completion of the IV therapy regulation review, the competency checklist and IV Therapy test will also be reviewed and updated.

Revised Reapproval Checklist:

C. Moreland stated she has updated the revised reapproval checklist as requested, and changes have been made to include letters and numbers to make the checklist easier to maneuver.

Five-Year Combined Statute and Regulation Review Process:

C. Moreland discussed the review process of combining the Statutes and Regulations to review simultaneously. Discussion was had on how to proceed. It was recommended the entire list be presented at the December meeting, and then decisions will be

made on which statutes and regulations will be reviewed at each future meeting.

It was moved to approve the 5 Year renewal application from B.E. Education Group LLC, LT0258-0310 with a recommendation to ensure teaching with updated references.
