New Business:	<u>Up-To-Date</u> - M. Kidwell noted Stormont Vail Health Care is requesting consideration from committee to accept CNE contact hours from the provider Up-To-Date. Certificate and Transcript deficiencies discussed. M. Kidwell noted discussing with Stormont Vail Health Care the transcript and the deficiency of the topic content hours being less than 30 minutes. Stormont Vail Health Care representative C. Bonjour proposed that they could educate their nurses letting them know that the contact hours could be accepted when topic titles are greater than 30 min, if agreed to by Committee/Board. The Consensus of committee is for KSBN staff to correspond with Stormont Vail Health Care recommending that they apply these offerings under their approved LTP as an independent study, assuring it meets KSBN LTP requirements. Then they would be able to issue nurses certificates that meet regulatory requirements.
