- Unfinished Business:**
HB 2280 Update: Mary Blubaugh discussed the House Bill 2280. HB 2280 has been changed to HB 2732 which will give Midwives some independent practice. HB 2732 was then voted out of full house. They then added the language from HB 2732 to Senate Bill 402. Doesn't have to go back to Senate for approval it just needs to be reviewed by conference committee to work on language (3 from the House and 3 from the Senate). If they can come to an agreement it will then go back to the conference committee to either agree or disagree. This House Bill was then given a new House Bill number of HB 2615. In this bill it also included language HB

2456, SB 402 and SB 449 which included language from three other bills for the conference committee to conference on. Nothing was decided before the House adjourned. They will reconvene on April 27th, not sure if HB 2615 will be addressed at this time.
