Announcements: Carol Moreland had two announcements.
1. Karen Smith who distributes fingerprint cards to the nursing programs will be retiring on March 12, 2018.
2. As discussed previously the KBI is looking at changing the current fingerprint process. The KBI initially was looking at a single vendor to process fingerprints across the state. That contract with the single vendor has been terminated. The KBI is now looking at getting designated law enforcement agencies across the state to process the fingerprints.

development in preparation of the new curriculum. With changes current pass rates is at 81.82%. Next site visit will be on February 8 & 9, 2018.

Rationale for the change: St. Gregory's University, Shawnee, OK BSN nursing program closed in the fall of 2017. With the closing of the nursing program approximately 5-10 student nurses were displaced.

Benedictine College would like to assume 5-10 student nurses in order for the students to be able to complete their BSN program.

A needs assessment will be conducted to determine what nurses are needing. Working with Johnson County Community College IT department to put together a survey electronically to be distributed to nurses across the state.

RN Refresher Course Completion Numbers: Carol Moreland discussed that the Board in September asked for course completion numbers from Newman University and Johnson County Community College. These numbers don't reflect how many are completing the refresher course.

Site Visit Schedule: The 2018 Nursing and MHT Program Site Visit Schedule was reviewed. Miriah Kidwell will be emailing committee members requesting assistance with the site visits, if needed.

Military Articulation Initiative: Monica Scheibmeir, PhD, APRN, FAANP gave an update on the Military Articulation Initiative. We have two ADN programs and nine BSN programs who have signed on to do the GAP analysis. The next meeting

is scheduled for January 2018 with plans to conduct monthly meetings going forward.
