APRN Rules & Regulations:

Michelle Knowles brought to the APRN Committee a request from members of the Kansas Advanced Practice Nurses (KAPN) to update the Kansas APRN Rules/Regulations to reflect the NCSBN consensus model language. They presented four major areas of concern: a definition of APRN that reflects current practice, requirement of national certification, changing authorization for prescribing drugs, and removing the medical plan of care language that was added but isn't supported by statute. Discussion about this request occurred with APRN Committee.
