certification. Until rules and regulations are revised or legislations regarding the Nurse Practice Act changed we cannot require certification.

Nurse Midwife Council:

BOHA CNM-I Regulations: Carol Moreland, MSN, RN reported that Cara Busenhart and Diane Glynn, JD, RN, KSBN Practice Specialist will be meeting with the Board of Healing Arts to discuss concerns brought forward by the APRN Committee and the Board of Nursing and work on resolutions to be able to move forward the CNM-I Regulations for approval.
