It was moved to accept the Major Curriculum Change Request from University of Kansas DNP Program to remove NRSG 731 Pharmacokinetics and Pharmacodynamics (1 credit hour), reduce NRSG 806 Advanced Physiology from 4 credit hours to 3 credit hours, add NRSG 938 Informatics and Technology Applications (2 credit hours) and add NRSG 948 Advancing Organizational and Clinical Quality (2 credit hours).

In addition, requesting restructuring and realignment of courses within the ADN program to better prepare students for the NCLEX-RN and practice as a registered nurse.

One of the amendments that was made during out special board meeting was to have the nurses register with our agency when they work in Kansas. C. Moreland was told by the Interstate Commission that the register amendment would make it impossible to join the compact. It was reviewed and amended so the nurse can

register voluntarily. KSBN received a grant from NCSBN for implementation costs. There will be a \$92,000 implementation costs that will be covered by KSBN so C. Moreland will ask for appropriations for FY19.
