Call to order:

Jo Klaassen called the general session of the Investigative

Does the committee want a case open? and 2) the number four's where there is action on a nurse in another state that does not have a current active license in Kansas. In the past a case was open. To better utilize the Investigative Staff time would the committee be open to the possibility of putting a hold in the MYLO database with notes and if the nurse should try to reinstate their license in Kansas. They would at that time be required to provide us with the required documents pertaining to the action for consideration of reinstatement of their Kansas nurses license. The consensus of the committee on the first question is to not open a case unless the complaint is specific and on the second question to put a hold in the MYLO database with notes on any nurses who have an

action put on their license in another state.

Draft revisions to the Discipline statutes

Definition of lapsed license vs. unlicensed practice

J. Klaassen discussed the definition of lapsed license versus unlicensed practice. We changed the definition in statutes to lapsed. Going forward we will have both a lapsed license as well as unlicensed practice. We just disguised between the two.

It was the consensus of the Committee that the Board of Nursing will not provide guidance on specific CE sites. The nurse who has been disciplined will be required to locate, complete and submit the CE on their own time.
