PMP Committee Report: Carol Moreland, MSN, RN read Bobbe Mansfield's report. The

> KTRACS Advisory Committee was held on February 22, 2019. The following items were discussed: 1) Board of Pharmacy working to educate State Legislators about the value of the KTRACS program and to request permanent state general funding for program sustainability; 2) completion of a document that established criteria for the Advisory Committee review and referrals related to KTRACS data; 3) met with representatives from Medicaid Fraud

and Abuse, KBI, Attorney General Office and DEA to discuss how to manage cases of concerns from Advisory Committee; 4) Referral to appropriate Professional Regulatory Board and 5) Advisory Committee has begun to review individual cases and making referrals. Still working on obtaining funding for KTRACS from Legislative State General Fund.

Nurse Midwife Council Rpt: Cara Busenhart, PhD, CNM, APRN reported there was nothing new to report as the Nurse Midwife Council has not met since November 2017. The Board of Healing Arts was given documents in October 2018 for review and as of today the Nurse Midwife Council has not received any feedback from the Board of Healing Arts.

HB 2066:

Carol Moreland reported on the amended House Bill 2066. Changes were made on the diagnosis for APRNs, transition to practice hours for a graduate before having full practice authority would be 2000 hours and malpractice insurance for APRNs under Health Care Stabilization Act. The House did change the transition to practice hours from 2000 to 4000. The Board of Nursing supports this bill with these amendments.
