- Call to Order:** The Continuing Nurse Education Committee meeting was called to order in room 560 of the Landon State Office Building at 1:00 p.m. by S. Brown
- Add/Rev. Agenda:** The December 2018 Committee Meeting was added to New Business. KAR 609-9-105 was added to Draft Regulation Changes; The Nurse Education Specialist Report was added, which will include the discussion of the LTP Relinquishment of Mercy Hospital Fort Scott due to hospital closing on 01/31/19. - Minutes:** The minutes for the September 2018 CNE meeting were tabled for review until June 2019 due to committee members not having access to the draft minutes.
- Ed. Spec. Report:** Several vacant committee positions were filled. There are currently 109 Long-Term Providers and 31 Single Providers. In December, there were 113 IOAs received; in January, there were 99 IOAs received; in February, there were 56 IOAs received. Over those three months, more than 7,000 CNE credit hours have been approved and 24 hours have been denied. Concerns brought to the committee – can a workplace violence training be applied towards CNE? Also, can a recorded CE be recorded and viewed at a later date to grant CNE? No further discussion was had regarding these matters.
