**Call to order:** The APRN Committee meeting was called to order by Carol Bragdon, PhD, APRN, Chair, at 2:02 p.m. in Room 509 of the Landon State Office Building.

**Minutes:** The minutes from the June 11, 2019 APRN meeting were reviewed. It was moved to approve the June 11, 2019 APRN minutes as revised. Motion #1 Mansfield/Bendure Adopted.

**Unfinished Business:**

PMP Committee Report: B. Mansfield reported on the PMP Committee Report.

Nurse Midwife Council Rpt: There was nothing to report.

CNM-I Proposed Reg: C. Moreland reported the CNM-I Proposed Regulations have been stamped through the Division of the Budget and the Department of

Administration. They are currently with the Attorney General office.

HB 2412: C. Moreland reported on House Bill 2412. This is the APRN bill for full practice authority. HB 2412 has an implementation date of 7/1/2020. Regulations would need to be changed before the implementation date. This is a lengthy process as it goes through the Department of Budget, Department of Administration and the Attorney General (AG) office. There is an option for temporary regulations, but these are only good for 180 days. We would still need to submit regulations for permanent changes.

5-Year Legislative Review: It was moved on K.A.R. 60-13-101 to approve the payment of fees for registered nurse anesthetists. Motion #2 Bendure/Mansfield Adopted.

K.A.R. 60-13-103: C. Moreland reported on K.A.R. 60-13-103 that we were trying to change the standard for accreditation nurse anesthetist programs. The AG office will not approve this regulation as the statutes will need to be changed from master's level to doctorate level.

K.A.R. 60-13-104: C. Moreland reported on K.A.R. 60-13-104 that we were trying to change the name to show the updated name of national board of certification and recertification. The AG office advised that this regulation needs to be revoked because the regulation reads the Board is going to annually approve the content outline of the examination exam and according to the AG office this should not be in regulation it should be a motion that is done on an annual basis.

It was moved to revoke K.A.R. 60-13-104 and to substitute approval of the content outline of the examination administered by the national board of certification and recertification for nurse anesthetists by motion of the board. Motion #3 Mansfield/Bendure Adopted. Harrington Opposed.

**New Business:**

APRN Program Approvals: It was moved to approve the following out of state schools and their below noted programs as meeting the board's criteria:

- a. Daemen College – Adult-Gerontology Primary Care NP
  - b. Florida International University – Adult NP
- Motion #4 Zeller/Mansfield Adopted.

Liability Insurance: C. Moreland discussed the dilemma of liability insurance for Manya Schmidt, CNM, APRN. Manya is licensed as a Nurse Midwife in

Kansas. In her practice she does not do obstetrics. As a licensed Nurse Midwife there is the Health Care Stabilization Fund that she pays into that is quite costly. She was licensed as a Nurse Practitioner and let that license lapse when she became a Nurse Midwife. She would like to let her Nurse Midwife license lapse and reinstate her Nurse Practitioner. Since it's been more than 5 years since her Nurse Practitioner license has lapsed, she would be required to do a refresher course. She would like to use her knowledge in her practice as her refresher course. A consensus of the APRN Committee is to have a sub-committee look at this and see if we can come up with something a little more definitive not only for Manya but for future NP's or CNM's that might find themselves in the same place.
