New Business**

FY19 Annual Report Data:

L. Davies discussed the Annual Report data. Stated that the IV certification goes into MyLo Licensing software but has found that it does not sync to *NURSIS*. The employer therefore, must check the KSBN Verification Database for IV Certification status of the LPN. A letter addressed to the LPN achieving IV Certification has been modified to include this language to further educate their employers. Data from the annual report also indicated that there was a drop to 87% in the Pass Rate for LPN's taking the IV Therapy Certification Course. From a conversation with all IV Therapy providers, it was mentioned that this drop might be due to the didactic portion being done online. Providers also reported that their classes may be full but are noticing that they have a last-minute withdrawal which makes it difficult to take an LPN off the wait list. .


Status of Regulation Revisions:
