NCSBN Nursing Outcomes and Metrics Committee:

- Member of the committee since 2017
- Committee outcomes: Establish a set of outcomes and associated metrics to recommend processes to assess nursing education programs
 - Review current literature on program approval metrics and their relevance to public safety
 - Recommend factors in addition to first time NCLEX pass rates that can be used to determine criteria for a legally defensible Board of Nursing's approval/removal process

- NCSBN Board of Directors approved for a study to be completed that we participated in. This study will look at annual reports and site visit reports for the past five years for all nursing programs.
- Committee met in October to review the results of the study. The results were not available because of the large number of documents submitted, so the results will be emailed out to Committee members when available.
