KSBN Update

There are licensing requirements that must be met before a license can be issued, which includes information that is reviewed and processed. Due to the high volume of applications and information KSBN is receiving that must be reviewed and processed, processing times may be longer than usual. Please continue to check your application checklist as we will update it as information is processed. It slows processing times when staff must respond to numerous emails and phone calls as to whether a piece of information has been received and processed. Another important reminder, licenses are issued on an individual basis and times may differ for each applicant. Agency staff are working diligently to process applications and required information. We want to get applicants licensed as soon as possible. Due to social distancing requirements, we must limit the number in our lobby to no more than one at a time. It is highly recommended that you conduct your business with the Board of Nursing via online services, mail, phone call or email or by making an appointment (785-296-2967). There is a secure drop box located outside of the agency that is available for anyone to drop off documents for the Board of Nursing. KSBN NO longer performs fingerprinting services in the agency. There is a list of the sites with contact information on our website. The

majority of staff continue to telework to decrease possible exposure. The best way to contact them is via their email. You may find our direct agency contacts information listed under Staff Directory on our website. Please continue to follow our website and social media [Twitter and Facebook] and our COVID-19 Information Center for agency updates and frequently asked questions.

KSBN has changed some processes during this pandemic to meet the restrictions of gatherings, promote safety for all and to streamline some processes in our agency. Some changes that have occurred include:

- First ever virtual committee and board meetings held in lune
- Individual Offering Approval has been changed to an electronic submission
- Controlled Substance Verification Form has been changed to an electronic submission
- Individual IV Therapy Application has been changed to an electronic submission
- Faculty Qualification Report has been changed to an electronic submission

House Bill 2016

House Bill 2016 was passed by the Legislature in the Special Session of 2020 and signed by Governor Kelly with an effective date of 6/9/2020. This act concerns the governmental response to the 2020 COVID-19 pandemic in Kansas. It contains provisions that impact nurses supporting a healthcare facility's response to the COVID-19 pandemic, which may not be all nurses. Here is a brief overview of the provisions that pertain to nurses that meet the criteria:

- The state of disaster emergency continues in existence from March 12, 2020 through September 15, 2020
- APRNs employed to support a facility's response to the COVID-19 pandemic may work as necessary without direction and supervision from a responsible physician. RNAs may work as necessary to support the facility's response to the pandemic without direction and supervision from a physician (expires 1/26/2021)
- RNs or LPNs may order the collection of throat or nasopharyngeal swab specimens from individual suspected of being infected by COVID-19 for the purposes of testing (expires 1/26/2021)
- LPNs may provide healthcare services appropriate to their education, training and experience when employed or contracted to work to support the facility's response to the pandemic without direction from a RN (expires 1/26/2021)

- RNs or LPNs who hold a license that is exempt or inactive or whose license has lapsed within the past five years may provide healthcare services appropriate to their education, training and experience (expires <u>1/26/2021</u>)
- Allows a registered nurse who is serving in the military to volunteer or work within a facility in roles that are appropriate to their education, training and experience (expires 1/26/2021)
- A nurse licensed and in good standing in another state may practice as a nurse in the state of Kansas (expires 1/26/2021)
- Nurses meeting the requirements of this act may have their license reinstated within five years of lapse without the requirements of continuing education and payment of a fee. Nurses wanting this provision will be given a temporary license that expires on 1/26/2021. After that date, the nurse may apply for reinstatement of license and meet the requirements of reinstatement.

As a reminder, all these provisions impact nurses supporting a healthcare facility's response to the COVID-19 pandemic, which may not be all nurses. There is a link to HB 2016 on our website.

June 2020 CNE Committee

The CNE Committee was called to order by Julianna Rieschick, MSN, RN, NEA-BC, Chair at 12:30 pm on June 17, 2020 via conference call. Minutes from December 10, 2019 were approved.

The IOA Statistical Report was reviewed. Carol Moreland, MSN, RN reported the IOA submission process is not electronic through KSBN's website.

Johnson County Community College, LT0027-0549 and Miami County Medical Center, LT0212-0772 voluntarily relinquished their CNE Providership with KSBN.

It was moved to approve the Long-Term Provider Renewal Application for B.E. Education Group, LLC- LT0258-0310 from April 1, 2020 through March 31, 2025.

It was moved to approve the Long-Term Provider 5 year renewal application for Manhattan Area Technical College – LT0260-0710, from April 1, 2020 through March 31, 2025, with recommendations. The following was missing from the LTP Renewal Application: provider numbers should be listed on the certificate of attendance; number of contact hours awarded should be listed on the certificate of attendance.

The following was missing from the LTP Renewal Application: the sample daily roster submitted did not include the participant's signature.

It was moved to approve the Long-Term Provider Renewal Application for Case Management Society of America, KC Chapter – LT0206-0606, from July 1, 2020 through June 30, 2025 with recommendations. The following was missing from the LTP Renewal Application: the language was not correct on all the offering announcements submitted, in alignment with K.A.R. 60-9-107 (b)(3)(C).

The Long-Term Provider Renewal Application received from Remedy Health Care Consulting, LLC, LT0293-0615 is

missing too many components. Carol Moreland will contact the provider to resubmit a new application.

It was moved to approve the Long-Term Provider Initial Application for Interim Healthcare from June 16, 2020 through June 30, 2025, with recommendations. The following was missing from the LTP Initial Application: the language was not correct on offering advertisements or announcement, in alignment with K.A.R. 60-9-107 (b)(3)(C).

It was moved to approve the Long-Term Provider Initial Application for The Nursing Connection from June 16, 2020 through June 30, 2025.

The Long-Term Provider Application received is missing too many components. Carol Moreland will contact the provider to resubmit a new application.

Nurses at Meadowlark have a unique opportunity

The 2019 NCLEX First Time Pass-Rates were reviewed for Kansas programs. The Kansas average PN pass rate increased from 2018 rates and is well above the national average. Average RN pass rate decreased from 2018 rate and is slightly below national average. Three RN and seven PN programs had a 100% pass rate with another 14 RN and 12 PN programs above the national averages. Seven RN programs were below the 75% standard for Kansas. One program has been below 75% for 2 years and one program for 3 years; per policy one will receive a letter asking for a Program Improvement Plan related to passrates, and one will be scheduled for a focused site visit this fall, respectively. Pass-Rates may be posted on KSBN's website.

Board reviewed a document submitted by Pratt Community College ADN program on Strategies to Improve RN NCLEX Pass Rates. No action taken.

Board held discussion regarding expectations for nursing programs for Fall 2020 in light of the COVID-19 pandemic. Regulations must be followed and there are no Executive Orders that impact nursing programs. Board continues to allow that a Major Curriculum Change Request (MCCR) is not required for temporary changes in course methodology due to pandemic. If a decision is made by the school to

make a change permanent, then a MCCR should be submitted.

IV Therapy regulations for LPNs were revised and finalized in January 2020. A Major Curriculum Change Request (MCCR) is required for any PN program wanting to add the IV Therapy content to their program regardless of previous approval to adopt the PN Core Curriculum. New regulations require the MCCR. Programs will need to provide a list of students to KSBN who successfully complete the PN program that includes the IV therapy content. List should be submitted on the Board-approved roster template.

A draft of updated site visit guidelines which include new guidance on virtual site visits was reviewed. Board asked that a team be assembled to review the draft further and discuss policy moving forward. Team will convene and report back to Board in September.

Site visit schedule for Fall 2020 was reviewed. April site visits cancelled due to COVID19 are being rescheduled into the Fall 2020 schedule. Janelle Martin will email committee members for assistance with site visits as needed.

Eleven petitions for permission to test/retest were reviewed and action taken.

The meeting was adjourned at 11:59 am.

June 2020 APRN Committee

The APRN Committee was called to order by Carol Bragdon, PhD, APRN, Chair on June 16, 2020 at 2:00 pm via conference call. Minutes from December 10, 2019 were approved.

Bobbe Mansfield, DNP, FNP-BC reported on the PMP Committee Report. The impact of K-TRACS continues to grow. There have been some grants issued to the Board of Pharmacy to assist with expansion. Carol Moreland, MSN, RN reported on K-TRACS funding for FY 2021. The Board of Pharmacy has been able to get grants and this will enable KSBN's fee fund will not be impacted in FY 21.

Cara Busenhart, PhD, CNM, APRN reported the CNM-I proposed regulations are still in progress.

It was moved to approve the following out of state schools and their noted programs as meeting the board's criteria: Alverno College – Family NP and Old Dominion University – Neonatal NP.

Carol Moreland, MSN, RN suggested providing links on the KSBN website to direct CRNAs and CNMs to the Healthcare Stabilization Fund and add it to the APRN application to make applicants aware. There was a consensus of the Committee to add a link to the KSBN website to direct CRNAs and CNMs to the Healthcare Stabilization Fund website and to add to the APRN application.

The meeting adjourned at 2:50 pm.

Investigative Committee

The Investigative Committee was called to order on June 15, 2020 by JoAnn Klassen, RN, MN, JD, Chair. The meeting was held via conference call due to pandemic. The minutes from the December 9 & 10, 2019 committee meeting were approved. The minutes from the April 27 & 28, 2020 committee meeting were approved. Linda Davies, Practice Specialist discussed the waiting period for new graduates to take the NCLEX with Pearson Vue. New employees, Nicki Snodgrass, RN Investigator, Evan Faulkner, Special Investigator, and Victoria Bond, Administrative Specialist were introduced. Carol Moreland, Executive Administrator discussed the records retention policy. Legislative review included approving KSA 65-1121, KSA 65-1129 and KSA 65-1135. The committee moved to deliberate on matters relating to decisions involving the exercise of quasi-judicial functions as authorized by KSA 2013 Supp. 75-4318(g)(1). Meeting was adjourned.

CNE Guidelines for Advanced Practice Nurses

K.A.R. 60-11-113(b) reads "License renewal, on and after January 1, 2013, each individual renewing a license shall have completed the required 30 contact hours of approved continuing nursing education (CNE) related to the **advanced practice** role during the most recent prior license period. Proof of completion of 30 contact hours of approved CNE in the advanced practice nurse role may be requested by the board.'

Guidelines for advanced practice nurses seeking continuing nursing education offerings:

Compare the course learning objectives/outcomes for any course you are considering with the definition of Continuing Nursing Education: Continuing nursing education means a learning experience intended to build upon the educational and experiential bases of the advanced practice nurse for the enhancement of practice, education, administration, research or theory development to the end of improving the health of the public.

- Is the course designed to provide new knowledge or enhance current knowledge and/or skills in your advanced practice role, to assist you in improving the health of the public?
- Is the course designed to provide you with the skills and/or knowledge to provide innovative changes supported by research and theory within your advanced practice role, to assist you in improving the health of the public?

- CME's are continuing medical education (not continuing nursing education) and must be submitted and approved by the Individual Offering Approval (IOA) process, prior to renewal of license
- If the CNE certificate of completion does not clearly indicate being approved for advanced practice nurses, you must submit the course learning objectives with the certificate for proof of advanced practice continuing nursing education, if audited or reinstating your license



Frequently asked questions to the Kansas State **Board of Nursing**

Question: What is the scope of practice for an LPN?

Answer: K.S.A. 1113(d)(2) The practice of nursing as a licensed practical nurse means the performance for compensation or gratuitously, except as permitted by KSA 65-1124, and any amendments thereto, of tasks and responsibilities defined in part (1) of this subsection (d) which tasks and responsibilities are based on acceptable educational preparation within the framework of supportive and restorative care under the direction of a registered professional nurse, a person licensed to practice medicine and surgery or a person licensed to practice dentistry.

KSA 1113(d)(2) sets three qualifiers for LPN practice: 1) an LPN must have a supervisor that is an RN, someone licensed to practice medicine and surgery (M.D. or D.O.) or a dentist 2) an LPN must function in the area of supportive and/or restorative care; (3) an LPN's activities must be based on acceptable educational preparation. If these three criteria are met an LPN may engage in care, nursing diagnosis, (not medical diagnosis) treatment, counsel and health teaching, supervision, administration, teaching of the nursing process and execution of the medical regimen. These activities are most often limited by the LPN's educational preparation. Any post basic education obtained can be considered and should meet the industry standard.

Question: Can LPNs supervise RN/APRNs?

Answer: Yes. It is possible for an LPN to supervise other nurses but each LPN must be evaluated as to education/skill level. The LPN must have a supervisor (RN, MD or DO) overseeing their work. Caution LPNs & their supervisors need to think about how they will prove education/skill level. LPNs supervising RNs is the odd case scenario for two reasons: 1) finding the qualified LPN w/the skill set & 2) the cost to the business to employ the LPN who also requires a RN supervisor (who could simply do the job themselves). Facilities must also consider federal law

by offering residency programs to new and experienced RNs. Multi-state Licensure

The COVID-19 pandemic has caused fear among all of us. Nurses want to help in any way they can, whether in Kansas or in other states. We have received many requests during this pandemic to convert a single state license to a multi-state license. The process to do that conversion has not changed due to the pandemic. We still must verify the eleven uniform licensure requirements for every multi-state license we issue. This has not changed due to the pandemic. The eleven uniform licensure requirements include:

- 1. Meet the home state's qualifications
- 2. Graduate from qualifying education program (or graduated from a foreign program verified by independent credentials review agency)
- 3. Passed English proficiency exam, if graduate from a foreign nursing program
- 4. Pass the NCLEX exam (or state board test pool exam)
- 5. Have no active discipline on a license
- 6. Submit to state/federal fingerprint-based criminal background check
- 7. Not be currently enrolled in an alternative program
- 8. Self-disclose participation in an alternative program
- 9. Have no misdemeanors <u>related to practice of</u> <u>nursing</u> as determined by the state board of nursing on a case by case basis
- 10. Have a valid U.S. Social Security number
- 11. Have no prior state or federal felony convictions

If you have a multi-state nursing license from your state of residence you can practice nursing in all 34 states that are members of the Nurse Licensure Compact. Information and the application to convert your single state Kansas nursing license to a multi-state nursing license is available on our website. Please ensure you will be able to meet all the eleven uniform licensure requirements before you submit an application for a multi-state license. There are no exceptions for the eleven uniform licensure requirements.

K-TRACS has positive impact in prevention



According to a recent survey, 97% of K-TRACS users believe the program has a positive impact on preventing prescription drug misuse, abuse and diversion in the state of Kansas.

K-TRACS is the state's prescription drug monitoring program (PDMP). Pharmacies are required to report prescription drug data on controlled substances (Schedule II-IV) and drugs of concern within 24 hours of dispensation.

There is no state mandate to query the system before prescribing or dispensing, but many prescribers and pharmacists choose to do so. Many RNs and LPNs are also registered K-TRACS users and assist their prescribers with collecting patient prescription drug history.

- The most common clinical scenarios in which prescribers use K-TRACS include:
- Suspected misuse or "doctor shopping" behavior
- When patients request early refills
- Before prescribing or dispensing for new patients
- When considering a new controlled substance prescription

Over the summer, more than 2,000 Board of Nursing licensees completed a K-TRACS survey that gauged users' perceptions of the program and identified areas for improvement. Significant findings from user responses on the survey include:

- 95% of users believe the information provided about patients' prescription drug history in K-TRACS is accurate.
- About 24% of prescribers (including 25% of nurse practitioners) use K-TRACS on a daily basis. Nurses and pharmacy technicians are considered "delegates" in the K-TRACS system, and collectively, about 30% of delegates use K-TRACS on a daily basis.
- 89% of users have adequate knowledge and training to use K-TRACS appropriately.
- Additionally, 2,138 non-user responses from primarily nurses were collected. Those responses show:
- A lack of understanding of what K-TRACS is and how it is being used in the state - this could be due to nurses working in sectors such as nursing homes, schools and hospital departments such as ICU where K-TRACS may not be needed.
- A number of facility policies in place to restrict K-TRACS usage to prescribers only. •

Reminders about the Controlled Substance Verification Form

What is this form?

K.S.A.65-1130 (d) states an APRN may prescribe drugs pursuant to a written protocol as authorized by a responsible physician. Each written protocol shall contain a precise and detailed medical plan of care for each classification of disease or injury for which the APRN is authorized to prescribe and shall specify all drugs which may be prescribed by the APRN. In order to prescribe controlled substances, the APRN shall (1) register with the federal drug enforcement administration; and 2) notify the board of the name and address of the responsible physician or physicians. For the purpose of this subsection, "responsible physician" means a person licensed to practice medicine and surgery in Kansas who has accepted responsibility for the protocol and the actions of the APRN when prescribing drugs. The federal drug enforcement administration requires verification of information and drug schedules from the Kansas State Board of Nursing before a DEA license will be issued. The Controlled Substance Verification Form (CSVF) contains the information we need to verify with the DEA.

Who needs to submit this form?

Any APRN that has a written protocol with a responsible physician that authorizes the APRN to prescribe controlled substances

How often do I need to submit this form?

When the written protocol is initiated and you need a DEA license and when there have been any changes to the information that was submitted (examples: change in responsible physician, change in schedules of controlled substances, etc.)

Where is this form?

It is located under the forms tab on our website. It will be changing to an electronic submission soon. There are directions with the form.

Reminders about Continuing Nursing Education

- If you have a multi-state license through your primary state of residence, you do not need to maintain a single-state license in Kansas. Your multi-state license allows you to practice in Kansas. You may let your single-state license lapse, so long as you maintain your multi-state license.
- Follow the CNE policy of the state in which you have your multi-state license. For example, if your multi-state license is through Kansas, you are required to obtain 30 hours of approved CNE before renewing your license. If your multi-state license is through Missouri, you would follow Missouri's requirements even if you are working in Kansas.
- 30 hours of approved CNE for renewal of your Kansas single-state or Kansas multi-state license must be obtained within your current renewal period, which are the two years preceding your expiration date. Example:
